

IT IS FURTHER ORDERED that the Clerk of the District Court of Nueces County, Texas, having Jurisdiction, to wit: the District Court of the 28th Judicial District, the 94th Judicial District, the 105th Judicial District, the 117th Judicial District, the 148th Judicial District, the 214th Judicial District, the 319th


